# **OUR AIM**

#### **OUR AIM**

Our aim is to adopt rural and remote villages which are lacking in basic infrastructure and other much required amenities like healthcare facilities, education, proper sanitation and good drinking water

#### **OUR OBJECTIVE**

## 1) ADOPTION OF VILLAGES

To adopt villages and provide healthcare services and educate villagers on prevention of sickness. We use technology mainly telemedicine, internet technology and use of modern gadgets to provide quality healthcare to remote masses.

Make the village self–sufficient and economically sustaining with each house in the village having sufficient income.

## 2) HEALTH CARE

To reach medical help to the needy at their doorstep by fully equipped TELEMEDICINE mobile van for medical care, treatment and diagnosis. The Mobile can also provides wide range of preventive and curative health services. To provide education to the villagers regarding cleanliness, to prevent diseases and health hazards.

#### TO ACHIEV THIS OBJECTIVE

We have adopted three villages at present and had number of free medical camps along with free distribution of medicines. The villages are Asjol, Zanzarva and Rudatal.

On permanent basis, we are seeking collaboration with reputed hospital having a fully equipped van with medical and para-medical staffs, to provide services to villagers at doorstep.

We are also working on tele-medicine by creating a BASE MEDICAL CENTER(BMC), which will be a rural hub, managing the villages around it. BMC will have a medical van and team to attend to the patients. The medical mobile van will have a medical team consists of trained para-medical staff who will attend to the villagers and connect to the doctor at the hub Telemedicine) to provide quality healthcare. Telemedicine system have data transfer facility along with audiovisual- enabled remote medical diagnostic device on a computer or cell-phone from Medisoft Telemedicine Pvt. Ltd.

#### WOMEN ENDOWMENT

We have a WOMEN SECTION for women empowerment activities at the villages. A group at the village level has also been established to provide the feedback and coordinate with our section.

#### **HEALTH CARE AWARNESS**

Apart from Multi-diagnostic health camps up and free medicine distribution camps, our objective is to prevent diseases by educating the villages to live a healthy life with clean environment. The basic nature of rural health problems is attributed also to lack of health literature, health consciousness, poor maternal and child health services along with occupational hazards.

The Villagers are to be shown videos, exhibits and presentation on various diseases and how to prevent such sickness and especially.

## **SWACHH BHARAT FOCUSING ON CLEANINESS**

we have entered into MOU with ATIRA for BUILDING TEXTILE REINFORCED CONCRETE MODULAR TOILET. With the help of ATIRA we can build toilets in all the rural and needy villages. We have already constructed 25 toilets in Asjol village.
