





LEDP Program Supported by NABARD









NABARD has supported DAPTA for LEDP program to implement for 120 SHG members to turn women vegetable farmers and mushroom cultivators . This program DAPTA started in the Tileibani Block of Deogarh Dist. Which started from October 2019. DAPTA has completed 4<sup>th</sup> phase of training during this year . In these training 90 numbers of Women trained on organic Vegetable cultivation and 30 numbers trained on mushroom cultivation . Also DAPTA has demonstrated these cultivation and women farmers took active participation in the entire process in which AGM NABARD, Sambalpur, LDM Deogarh, personnel's from SBI, OLM, ITDA, Agriculture Dept. Horticulture Dept. has witnessed all activities. In this program DAPTA has an intention to strengthen Women farmers for better income generation and better livelihood.

RURAL MART Supported by NABARD

DAPTA has facilitated to set up a Rural mart through the Women farmers Company

In the centre of Bhawanipatna which is managed by the Women farmers company. This program started from February 2020 with the support of NABARD Odisha. The main objective of the program is for better facilitation to sell products of farmers and other rural products.

Name of the project: Arrest Distress Migration by strengthening Agri-based livelihoods through INRM under MGNREGS, (Migration Control Project).





#### Supported By: District Rural Development Agency (DRDA) Kalahandi, Govt. of Odisha

The project is being supported by the District Rural Development Agency (DRDA), Kalahandi. The project envisages Creating durable livelihood asset and sustainable livelihood for the poor, tribal and other vulnerable households in 12 Gram Panchayats namely Chancher, Jugsaipatna, Gandbarajhola, Kuliamal, Kutrukhamar, Laxmipur, Malgaon, Risgaon, Sagada, Kamthana, Palsijharan, Talbelgaon of Bhawanipatna Block, Kalahandi district. The project was initiated to check the distress migration of people from the district and provide them with gainful employment under the MGNREGS.

The project team facilitated Integrated Natural Resource Management (INRM) based planning exercises in project villages. These plans are now linked with the MGNREGS for creating durable asset focusing on livelihoods. The implementation of the project activities ensured a combination of wage and self-employment for targeted rural households. Creation of household level asset base for land holders, marginal farmers and landless families was ensured.

The project facilitated Awareness generation at village/GP level, Organization of Rozgar Diwas, Mobilizing HHs to demand for work, Organisation of Shramik Sangha and Opening of Bank account. The project organized field level trainings of Shramik Sangh leaders. SHGs/CBOs and Mates. Thematic trainings were also organized for GRS and PRI members and barefoot technicians for measurement and worksite management. IEC materials were also designed and disseminated among targeted stakeholders. A Sahayata Kendra at the Block premises was made operational, where all job card holders will raise their issues, grievances etc. on a regular basis.

Orientation/Sensitization of SHGs/Shramik Sangha/community on planning process were done. All the key functionaries were sensitized on the various participatory planning processes. Annual action plans based on the INRM approach to address environmental risk were developed and a seasonality work calendar was prepared. The various participatory planning processes included resource mapping, Social mapping Livelihood analysis, Mapping of distress migrants and vulnerable HHs and development of HH wise sustainable livelihood plan.

7 training programme were conducted with District Rural Development Agency (DRDA), Kalahandi.


This project is implemented exclusively in convergence mode with the Government of Odisha under the MGNREGS.

The project was instrumental in assisting in timely payment of wages to the job seekers by tracking the Muster Roll, problem identification and dialoguing with Block Administration and concerned Bank to sort out the existing problems and identification of the new wage seekers and helping them to open the Account to realize 200 days of work per household.





Now the migrant laborers are earning regularly and living a decent life. Not only the migrant labour but also other villagers are working under the MGNREGS scheme and earning money for their livelihoods. Distress out migration from the villages has reduced significantly. People are now getting work at their own villages and are not interested to migrate out for work.



Name of Project: - Access to Alternative Clean energy for improved life and livelihood

Supported by SELCO Foundation.





**Project Objectives:**DAPTA with the collaboration of Selco Foundation started a joint initiative to increase the access of rural population to alternative clean energy for improved life with dignified livelihood. The programenvisages to reach out the rural population with solar energy-based livelihood solution by strengthening and adding value to the existing/new source of livelihood. The initiative was intended to enhance the opportunity of secured livelihood options in the vulnerable pockets (Lanjigarh and Bhawanipatna Block) in order to ensure improved quality of life of the targeted client and the community by linking them to alternative energy solution. The plan was envisaged, also to offer home lighting solution through solar energy to mitigate the electric power crisis in one hand and also to minimize the risk of climate change effect. The SHGs and the cooperatives were linked with alternative solar energy to strengthen their individual and group enterprises with added value and increased production capacity. Farmers, unemployed youth, women entrepreneurswere given the main focus.

- To support and promote sustainable livelihood activities including Farm and Off Farm for migrant prone tribal families and women farmers in Lanjigarh& Bhawanipatna Bock, Kalahandi by creating more socio-economic safety nets.
- 2. Build capacities of the tribal youth and women groups on rural livelioods and access Government livelihood schemes and other development programmes.
- 3. Support pilot initiatives with youth and women groups on sustainale agriculture and rural livelihoods and local feasible rural enterprise.

#### Activities carried out-

#### **Capacity Building**

**Orientation Workshop-**An orientation workshop was organized by Selco Foundation for the NGO IR partners at Bhubaneswar on 23rd and 24th Oct. 2019 by Selco Foundation where the Objective of the NGO IR programme was shared. The partners also shared their experience and expectations from the NGO IR visa-vis Selco Foundation. At the end of the workshop the partners gathered a lot clarity with regards to the objective of the NGO IR programme and also all the individual partners developed a draft, action plan of 6 months for the NGO IR Programme.

**Policy Implementation Workshop-** Following to the visit of Srividya ji and Ms. Harsha in the month of November 2019 a workshop was organized on 20th and 21stJan. 2020 at DAPTA office to re-visit and review the organization policy of DAPTA. The draft policy (prepared after the November visit) was thoroughly discussed with the staff members including the founder by Ms. Harsha and Sreevidya Ji. All the staff members and the Secretary of the organization shared theirs views, opinions and remarks about the draft organization policy. A draft policy was further refined and retune after certain rectifications and modifications taking into consideration the views and opinions of DAPTA and its staff members.





**Staff orientation on Energy Nexus-** A one day orientation was organized for the NGO IR partners at DAPTA office where the project staffs of DAPTA and Seba Jagat participated. The orientation was on 11th Dec.2019. Mr. Asit Ku. Purohit from Selco Foundation was the resources person in the workshop. The focus of the discussion was on different successful models of energy-based solutions. A workshop was immensely helpful to understand the successful models and its modus operandi. At the end of the day the participants were able to visualize a roadmap to roll out the proposed plan (NGO IR).

**Exposure Visit-**A 3 days exposure visit was organized by Selco Foundation at Manipal, Karnataka. The NGO IR project staff all partners participated including the heads of the organizations. The participants visited number of successful sustainable models and interacted with the entrepreneurs and groups. The participants were able to understand the implementation process and benefits by directly interacting with the entrepreneurs. The exposure visit was significantly helpful for all the partners to know the process like need assessment, feasibility study, leveraging resources (banks/financial institutions), client's contributions and process of recovery.

## Name of the project: Targeted Intervention Project (T.I, project)

Name of the Donor:Odisha State Aids Control Society (OSACS)

#### **Project Objectives:**

- Prevention infections through saturation of coverage of high-risk group with Targeted Intervention scaled up intervention in a general population.
- Provide greater Care, Support & Treatment to larger number of PLHAs (60%).
- Strengthen the infrastructure system 7 human resources in Prevention, Care & Support programmes at District, state and National level.
- Increasing awareness and knowledge about HIV/AIDS, ways of transmission, and ways of preventing transmission among the selected groups.

Number of Beneficiaries reached out: DAPTA reached out to 400 key populations. Out of which 310 are TG & 90 are MSM.


Major activities and outputs/major achievements of the project:

#### **HOTSPOT LEVEL MEETINGS:**

60 no. of Demand generation meetings organized with the help of our Peer Educator targeting the TGs and MSM in a regular interval in-order to reduce the vulnerability of the targeted key population through awareness and counselling. The objective behind the activity is to increase blood testing, protective sex. We also discussed on signs and symptoms of HIV/AIDS, STI/STD, uses and benefit of ART medicine & safe behavioural practices. During the year we covered 400 key populations through the hotspot meetings. 60 no of new HRG (key population) identified during the meetings.



**Health Camps:** DAPTA conducted 2 nos. of Health camp at Bhawanipatna and Dedara operational area. In this camp we covered 60 nos. of HRGs and checked up their health status by a Doctor and provide medicine as per their disease. We also organised a small awareness meeting on their personal hygiene, healthy life and advice them on HIV/AIDS, STD/STI and safe sex.



**World AIDS Day celebration:**World AIDS Day (1<sup>st</sup> December 2019) was observed this year at red cross Kalyani Mandap Bhawanipatna collaboratively both DAPTA & district health administration on 1<sup>st</sup> December 2019. About 146 peoples participated. An awareness rally was







organized. Among the participants there were key population (HRG), TI staff, Medical staff, ANM, GNM, ASHA, ANGANWADI workers and College students among the participants.

#### ADVOCACY MEETING WITH STAKEHOLDERS:

This year we conducted 3 nos. of Advocacy Meeting with different service providers of our project area. Objective of this meeting was to initiate the HIV testing of Key Population, linkage them to social scheme and give social justice in their day today life. It was decided to have proper coordination and mutual understanding with all service providers.




#### **Community Event:**

On 16th November 2019 TI Project DAPTA organized a Community event for creating awareness among the Key population at Jaipatna. On the eve of this occasion Mr. Subhranshu Sekhar Majhi (PM) briefed about TI Project, Components of TI Project ,HIV AIDS and about PLHIV .In this Community Event large no of Key Population were present.

**Plantation Programme:**On the occasion of Bahuda Yatra, DAPTA organized a plantation programme with the help of T.I Project supported by MSM/TG Community at BabajiPahad Hotspot near devi Sagar, Bhawanipatna. In this day we organized a small Demand generation meeting and also discussed on pollution free environment & usefulness of plantation.





#### Any convergence with Government schemes

 Two nos. of Self Help Group were formed and strengthened and linked with the DSWO, Kalahandi.





- 23 nos. of Transgender's Affidavit was done in this year.
- 5 nos. of HRGs applied for Madhubabu Pension Yojana.
- 30 nos. of HRGs applied for plot in JayapatnaTahashil.

#### Major changes in community effectuated due to the project interventions:

- They are able to understand the actual cause of HIV, STD etc., how its spread and
- They got proper knowledge on their rights.
- They understand the value of condom and how to use condom. Use free condom regularly.
- Before they had more number of sex partners. After our awareness they reduce their partners. They want to devote to a single partner.
- They got a basic knowledge on personal hygiene, cleanliness and nutritional food.

What work well and why?-DAPTA was able refer two numbers of migrant PLHIV LFU to the ART centre, Balangir and they diagnosed and continue their medicine because of our long effort towards the client with long term counseling, regular contact by our staff.

#### What did not work well and reasons

We didn't achieve the TB testing target because the shortage of falcon tube in hospital.

#### Way forward

- Behavioural changes in the community.
- They use condom regularly for safe sex.
- They know their health status.
- They go for RMC and HIV testing on their own willingness.
- They got strength to fight against social stigma and discrimination.
- PLHIV take ART medicine every day and go to hospital a lonely to know their health status.
- They able to get the benefit of govt. Scheme fight for their rights.

## Name of the project: Mother & Child Health Care – Follow u





Though this year DAPTA did not have any external support but we continued our effort through the village health volunteers since mother and child is one of DAPTAs prime mandate. Community meetings, Focused group discussions and early identification of malnourished children was part of the intervention. Through active referral 76 nos. of patients received appropriate diagnosis and treatment support. Apart from this the village swasthya sathis conducted monthly village meetings on malaria, diahorrea, pneumonia, malnutrition and anemia. The objectives of the meeting was to increase the required knowledge and skills of the targeted households in order to increase their resilience.

## Name of the Project- Mental Health - Follow up

The community health volunteers identify the PWMIs (People with mental illness) and bring them to the district head quarter hospital. The referral coordinator facilitate their diagnosis and treatment process. DAPTA covers Bhawanipatna and Lanjigarh Block of Kalahandi in this program. This year we have facilitated the treatment of 32 PWMIs. Apart from this DAPTA is also facilitating the disability certificates for the PWMIs.

**Health Camps:** DAPTAorganized 2 nos. of health camp during this financial year. In which we checked their health status by the doctors, diagnosed them and provide generic medicine to the children. If we found that any child suffering in some chronicle disease then immediately refer to the govt. hospital for their better treatment .In this camp we covered all the 100 students of our three canters.

**Special Day celebration:** In this occasion we observed and celebrated Special days and religious festival along with the students and community. Positive involvement of children, their parents and the community and give a basic knowledge on the celebration is the main objective of these events.

**Health Awareness Programme:** In this programme we aware the children and others on their personal hygiene, hand wash and nutritious food diet. We also show the demonstration of hand wash and prepare of nutritious food and the child also participate in this demonstration.

Major training conducted: We conducting one no. of 3 days teacher training programme with our 3 teachers and a resource person to increase the teaching skill of teachers. Any convergence with Government schemes:

After the children are getting appropriate level of knowledge we mainstreaming them to the government school for formal education.

## Major changes in community effectuated due to the project intervention:

They understand the value of education and encourage their children for their higher study. They can understand the responsibility of parents.

#### What work well and why?

We are mainstreaming 70% of children in govt. school from our three no. of centres.

#### What did not work well and reasons?

We did not mainstream 30% of students in govt. school during this year because some students did not have Adhar card which is essential for admission into school. So we decide to make their Adhar card in this year and enroll them.

Parents send their children to the institution regularly.
