

PRESIDENT'S OVERVIEW



Namaskar to all the esteemed members of the IIT Alumni Centre, Bengaluru!

I am happy to share with you that we had a good year for our Centre despite the entire year being under the Covid pandemic. We were able to maintain presentations of highquality Webinars that have been attended or viewed by an amazingly large number of people in India and abroad. We were arranging a Webinar every week but later in the year changed this to one every two weeks. Among other speakers, we have had the IIT Directors present very interesting lectures. All this was possible due to Susheela Venkataraman and Ashok Kamath – the Webinar champions. Ashok Kamath edited the first Volume with the first 10 webinars that has been available on our website. The second Volume of the next 10 webinars is ready for launch.

We have made great progress in the construction of our iconic building Bommasandra despite the delays due to the lockdowns. Our aim was to have a soft launch on August 15, 2021 and I feel that our next AGM will be from our very own premises. I must applaud the tenacity and the perseverance of the Building team led by Kumar Nadig along with Shanmugam. We have reached a stage when we can organize a visit to the centre for our members around Diwali this year. We still need about Rs. 6-7 crores to finish the interior work etc. and I would appeal to our members to help in raising the requisite funds for IITACB.

We are committed as ever to create a community and ambience that will enhance the interaction between the Industry and the IITs. You will be glad to know that we have



signed an MoU with KUIDFC for interaction with the IITs and a couple of projects are on the anvil with IIT Guwahati. We now have all the first and second generation IITs as our partners and we are in the process of getting the third generation IITs on board. I would like to thank our Management Committee members who have played a major role in enhancing our interactions with the IITs on one hand and industry on the other hand. The proceedings of our IIT-Industry Conclave held in February 2020 was published and shared with a number of Stake holders. Follow-up and progress on the recommendations slowed down due to the pandemic but we are poised to go forward as soon as things open.

Another landmark for us was that the University of Massachusetts at Amherst became our first institutional member; SRM Group of institutions being the next. We are in an advanced stage of talks with a few industries to become institutional members. We need the help of our esteemed members to have these to increase in the coming year. We also need to increase our membership numbers, which have been going up steadily.

IITACB is in an excellent position to make the difference in the country as we have envisioned over the years. It is a matter of great satisfaction that the IIT Alumni have appreciated our efforts and are coming forward to help us in numerous ways. It is this joint effort that will leapfrog us in the next few years to follow. With our building ready soon our presence will be better felt as it will become the hub for several our future programmes. Clearly, we need active support from every one of you for the fruition of our dreams and to contribute to the Indian society.

It has been an exciting journey for me personally to be a part of IITACB, a unique and vibrant organization with the support of a very committed Managing committee.

It is my privilege to welcome all of you to the AGM of IITACB today. Wishing you all the best for the 75th Independence Day of our great nation. Jai Hind!

SECRETARY'S REPORT

The Financial Year 2020-2021 was a difficult year as well as a fulfilling year in many different ways for IITACB. The Covid-19 pandemic brought many hurdles in our progress but it also forced us to think differently and keep the buzz around IITACB going – and, I believe, we have done well this year.

I would like to share with you all the successes your Centre has had during the course of the year.

- 1. We were able to sharpen our focus and articulate our goals better and it is best summed up with the following. In 2014, the then Governor General of Canada David L Johnston told a gathering of IIT Alumni in North America "As stewards, it is your responsibility to improve your institution, and to give back. To make it better for the students that will follow you. Your community has supported you. Taxpayers have shown their confidence in you by making a major investment in your future". Therefore, with this in mind we are striving to ensure that the glory that is IIT does not fade away and we can only do this when industry and society see the IITs as the powerhouses they are.
- 2. The construction of our brick-and-mortar Centre began in earnest from November 2018 and as on March 31, 2021, we have nearly completed the entire structure despite significant delays caused by the Covid-19 pandemic. From the Managing Committee of IITACB, Kumar Nadig and K.Shanmugham have dedicated many days of their personal time to manage the construction of this massive facility and, on your behalf, I would like to extend our thanks and deepest appreciation to them for their efforts. We expect to start functioning from the new facility before the end of this calendar year stay tuned for the dates for this soft launch of our new facility. Space for offices of all the first and second generation IITs have been provided for in this soft launch.

- 3. In earlier years, IITACB would host a Third Saturday Monthly Meet (TSMM) where we would have speakers from different disciplines and also bring in the IITs to speak to alumni in Bengaluru. Since the Covid pandemic we have been unable to do this and have started our Webinar series. During the year, IITACB hosted as many as 33 webinars and this has been very well received we have had sizeable audiences both live and watching the recorded videos on YouTube. And we have been fortunate to have very wide range of good speakers. Besides the webinars, teams at IITACB have been working hard to facilitate projects into the IIT system and we had our first success at the end of the financial year (in March 2021) when MEITY, Government of India gave a project to IIT Dharwad in collaboration with IIT Hyderabad and IIT Bhubaneswar for innovations in Natural Language Processing (NLP). Susheela Venkataraman along with Anand Talwai have been instrumental in getting this moving many thanks to them.
- 4. Our Membership has been steadily growing but, in the coming quarters, we would like to see an accelerating rate of memberships into IITACB. Our Membership Committee comprising M. Thiyagarajan and Seema Sibbal have worked tirelessly in cleaning up our databases and are available to respond efficiently to any membership queries. On behalf of the Governing Council, I would like to request all our members to bring in new members to IITACB – as and when you have leads, please do share them with us.
- 5. Our Finances have been very astutely managed by our Treasurer, Dhananjay Collur and many thanks to him for his unstinting efforts to bring in sponsorship revenue and also manage to maximize our earnings by making appropriate deposits we have, as you will see from our financial statements, got a substantial sum in interest and have not put our capital at risk.
- 6. During the year, we made substantial improvements in getting our social presence enhanced. Our new website is live and please do log into the website where you will see information on all aspects of IITACB. Moreover, you will also find links to all of our webinars, the webinar compilation(s), videos from the IIT Industry Conclave 2020, etc.





We would like to thank our Statutory Auditors M/s. S. Ramprasad & Co., for their professional services to your Centre. Finally, a big round of thanks to our office bearers – Prof. Ashok Misra, President PSV Ananthanarayan, Vice-President; Dhananjay Collur, Treasurer; and Susheela Venkataraman, Joint Secretary.

TREASURER'S REPORT FOR FY 2020-2021

I am happy to present the Treasurer's Report for the financial year 2020-21. During the last financial year, our total operational expenses was Rs.17.25 lakhs. On the income side, we received Rs.1.24 lakhs as event attendance fees and Rs.3 lakhs as logo sponsorship for Webinars. We also collected from Sundry Debtors an amount of Rs.5.15 lakhs. The balance cash flow was managed since we had an opening balance in the bank. We also collected Rs.29.93 lakhs towards Institutional and Life Membership. Year on year, we need to generate monies to run the Centre and the planned sources (till our new facility is fully operational) are as follows:-

- Sponsorship for events
- Banner advertisements on our web site
- Fees received from new members

I request all members to help us in raising money for Operating Expenses.

Towards our new building, apart from land, our spend has been Rs.10 crores. We have enough money to complete the structure and are looking to raise funding for interiors and for a small corpus.

We are looking at the following sources:-

- Balance money from IITs which is progressing well
- Donations from HNIs
- Funds for naming of auditorium, Incubation Centre, Seminar Halls, etc.
- Institutional Memberships

Here again, we are looking for active participation from our members in raising these funds, so any leads are welcome.





AI CENTRE OF EXCELLENCE

The objectives of the CoE are:

- To conceptualise and support projects to address issues of national/ social importance
- To support curation and creation of open resources for faculty and industry across the country (and internationally)
- To support development of skills and understanding of AI and related technologies
- To popularise adoption of AI technologies in industry

To ensure that these objectives are met, the AI Task Force was constituted with members from the IITs and Alumni with industry experience. Seminars and workshops are being planned to build skills in language processing and its relevant technologies.

PROJECTS:

 Speech to Speech Translation for Tribal Languages using Deep Learning Framework
 IITACB through the AI task force facilitated the conceptualisation of this project which has been awarded by MEITY. It will be executed through a collaboration involving multiple IITs,
 IIIT Dharwad, EkStep Foundation, and IITACB.

The objective of the project is to develop a Speech- To-Speech-Translation (S2ST) system for Tribal languages using a deep learning framework. The proposed S2ST translation will



help the tribal population to better understand information available in Indian English and also integrate with other communities using their own language. 4 tribal languages, Soliga and Lambani (Karnataka) and Kui and Mundari (Odisha) have been selected for this phase. The steering group drawn from across the various participating organisations conducts periodic reviews to assist in successful completion of the project.

2. IITACB signed a MOU with KUIDFC (Karnataka State body) to address urgent technologyrelated urban problems faced in Karnataka using the IITs

Problems Include:

- Sophisticated Instrumentation for water supply and allied services
- Advanced technologies for Pumps for raw water and pure water
- New technologies in Water Treatment Plants
- Designing and building distribution network systems for service delivery and monitoring.
- Civil Engineering issues; latest construction techniques, etc.





BUILDING COMMITTEE REPORT AS ON MARCH 31, 2021

SYNOPSYS:

- Located in Bommasandra Industrial Area, Bengaluru
- Architectural competition held on February 2nd, 2016
- Architects M/S. Chandavarkar & Thakkar chosen by the jury panel headed by Prof. Pradipto Banerjee, then Director of IIT Roorkee.
- Building plans approved by KIADB on November 11, 2018
- Bhoomi Pooja on February 11th, 2018
- Construction started on December 17th, 2018

Building design consists of 3 basements, Ground, Mezzanine and 3 upper floors. Total Built up area is about 94,000 Sft

Broad facilities includes an imposing large double height entry lobby, state-of-the- art Auditorium with 400 seating capacity, 2 Seminar rooms of 40 seating capacity, office / work area of 30,000 Sft, spread over 3 floors, roof top cafeteria, landscaped garden with amphitheater and various spill out / huddle spaces.







The project originally scheduled to be completed in 24 months, is scheduled to be completed by end June 2022. Much of the delay is due to factors beyond our control, starting from hard rock excavation, flooding of basement due to breach in the stormwater drain behind to Covid imposed lockdowns. Currently, the last terrace slab is in place, all civil works would be complete by end October 2021.

Finishing and Fit outs are planned in 3 phases:

Phase 1 Completion of Ground, Mezzanine and First floor office space, with fit outs. Mezzanine floor will house the building estate office and First Floor will house offices for 17 IITs.

Entrance lobby has been redesigned to be enclosed, with glazed curtain wall.









- Phase 2 Completion of Basement 1 & 2, office floors 2nd 3rd floor.
 Basement 1 has one seminar room with provision for another, Library and spill-out space for the Auditorium.
 2nd & 3rd floors house the Incubation Centre, and has space for a Centre of Excellence.
- Phase 3 Completion of 3rd Basement, Auditorium and the Roof top cafeteria. Completion of landscaping and amphitheater.



We expect the building to be partly operational by end November 2021, and fully operational by June 2022.
