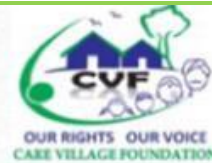

2. EDUCATION

Education is a primary and basic need of a civil society and teachers are the resources of this primary need. Here at Care Village Foundation, we have been relentlessly dedicated to the cause of education especially education of the girl child. It is the harsh truth of Indian society that most communities still do not allow their girls to be educated. At Care Village Foundation we have made it a mission to change this situation from the grass root level. We have organised awareness campaigns for families in the village and surrounding communities to sensitize them on issues of female infanticide and the importance of educating and investing in a girl child. We strongly advocate’s government of India’s “Beti Bachao, Beti Padhao” initiative and have organised counselling sessions for parents to send their girls to school. At CVF we have also initiated a programme on **non-formal education (NFE)** for children and also made efforts to ensure admission of children in school under the Right to Free and Compulsory Education Act, 2009.

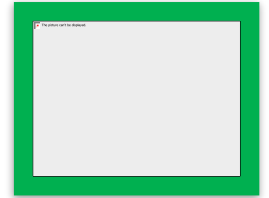

3. HEALTH PROGRAMMES

WHO has defined health as a “*State of complete physical, mental and social well-being, and not merely the absence of disease or infirmity*”. For the overall development of society, the importance of health is inalienable. The National Rural Health Mission launched in 2005 identified the need “to provide accessible, affordable and quality healthcare to the rural population, especially the vulnerable groups. In keeping with the spirit of this national mission, Care Village Foundation has taken a lot of initiatives towards healthy India mission. The foundation organises number of free health camps, advisory sessions, workshops etc. every year in association with various organisations/bodies working in the field of health and hygiene. The foundation is also playing a very active role in eradication of Tuberculosis in collaboration with organisations like Delhi Tuberculosis Association (DTBA). The awareness session on hygiene & sanitation is an integral part of other programmes as well. **There is also a weekly free eye check-up camp organised in partnership with AIIMS, Delhi. This camp is open to the any member of the public who wishes to take benefit of the camp.**



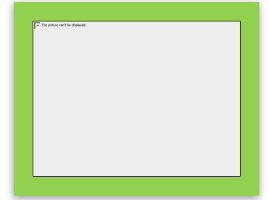

Free Weekly Eye Check Up Camp by AIIMS



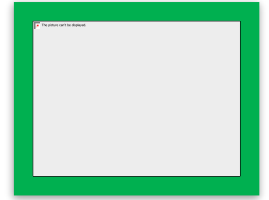


4. ENVIRONMENT AND SANITATION

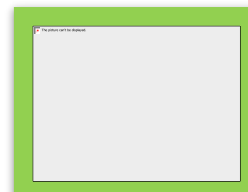
Times of India, in 2019 reported that India alone generate 100000 metric tonnes of garbage daily. Waste management, sanitation and environment protection continues to remain a challenge in India due to the lack of adequate planning and implementation and a large population number. However, despite all odds, on 2nd October, 2014, the Swachh Bharat Abhiyan was launched with the intention to accelerate universal sanitation coverage and to put focus on sanitation. Care village foundation since its inception has promoted cleanliness and sanitation in the society. On August 30, 31 and September 1 of 2019 a “Swachhata Abhiyaan” programme was conducted by CVF in collaboration with Nehru Yuva Kendra Sanghathan (under the Ministry of Youth Affairs and Sports). We received great response for the event and there was a huge turnout for participation in the clean-up drive. On 5th June, 2019, World Environment Day, an awareness campaign was launched for the ban on use of plastic and the participants were briefed on the ill-effects of plastic overuse and they were instead encouraged to use environment friendly alternatives.



Care village has also collaborated with South Delhi Municipal Corporation and Delhi Legal Services Authority for the development of 12 parks in J.J. Colony, Bakkarwala Village, Delhi.

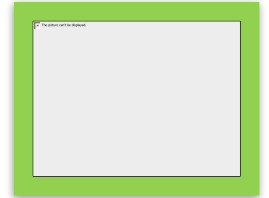

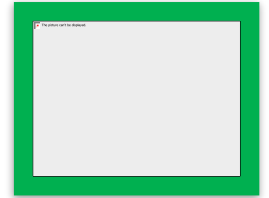

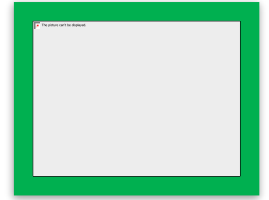


7. LEGAL AID AND COUNSELLING

Legal aid may be taken to mean free legal assistance to the poor persons in any judicial proceedings before the Court, Tribunals or any authority. It intends to provide free legal assistance to the poor persons who are not able to enforce the rights given to them by law. The constitution of India gives much importance to rule of law. In India, it is regarded as a part of the basic structure of the Constitution and also of natural justice. Free legal aid to the poor and weak persons has been held to be necessary adjunct of the rule of law.

Care Village Foundation has maintained a long standing collaboration with the DLSA. We have organized numerous activities with DLSA on various issues among people in need of awareness of their rights and liberties. CVF has organized awareness sessions across various areas in Delhi especially in West Delhi District for the public, among migrant workers, among school and college children, youths, women, senior citizens etc.

Care Village Foundation runs legal aid movement to the grass root level and helps to discover, identify and solve the problems and difficulties of the poor. The foundation ensures participation not only of the practicing lawyers but also of the courts through full co-operation and support from Delhi Legal Services Authority. CVF also promotes Lok Adalats through prompt settlement of disputes by counselling, discussion with elders and other members of the society, etc. It forms a basis to providing quick justice with the mutual consent of the parties.



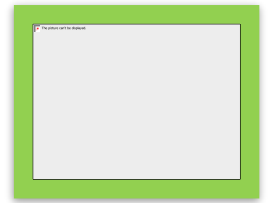
Formation and development of Self Help Groups (SHGs) in association with NABARD

One of the reasons for rural poverty in our country is low access to credit and financial services. The four major reasons for lack of financial inclusion are inability to provide collateral security, poor credit absorption capacity, inadequate reach of the institutions and weak community network. The existence of sound community networks in villages is increasingly being recognised as one of the most important elements of credit linkage in the rural areas. They help in accessing credit to the poor and thus, play a critical role in poverty alleviation. They also help to build social capital among the poor, especially women. This empowers women and gives them greater voice in the society. Financial independence through self-employment has many externalities such as improved literacy levels, better health care and even better family planning. Self-Help Groups (SHGs) are informal associations of people who choose to come together to find ways to improve their living conditions. It can be defined as self governed, peer controlled information group of people with similar socio-economic background and having a desire to collectively perform common purpose.



Care Village Foundation is working for creation and to sustain these Self Help Groups for socio-economic development of the society. These efforts are being done by the organisation in some states like Uttar Pradesh, Jharkhand, Uttarakhand and Delhi since long independently and in association with NABARD at Mardah, Distt. Ghazipur, UP with a target of 100 SHGs. Meetings of these groups are being organised at the head office and regional offices of the organisation besides the nearby common and suitable place of the community or members of SHGs. They are told the way of self independence with collective efforts.

In April, during such community meeting about 150 women participated in this meeting. Discussion was held for creation of new SHGs, linking of existing SHGs with banks, loan through not banking system,



maintenance of record of SHGs, opportunities of self employment. Women were encouraged to create SHGs at their own and start working independently or jointly. Care Village foundation organized several other such meetings of ladies and youth passionate to defeat the poverty through collective efforts in Delhi and various districts of UP including Mardah- Ghazipur, Ballia, Bhadohi and Mau of UP state.

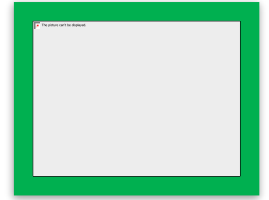
Formation and development of Farmers Producers Organisation(FPO) in association with NABARD

A Producer Organisation (PO) is a legal entity formed by primary producers, viz. farmers, milk producers, fishermen, weavers, rural artisans, craftsmen. A PO can be a producer company, a cooperative society or any other legal form which provides for sharing of profits/benefits among the members. Care Village Foundation hold several meetings with such POs for providing support for promotion of FPOs so that they may be linked with the market offline/online so that the genuine share of profit can be reached to the original producer. The FPO is being formed at Mardah, Distt. Ghazipur, UP for fishery production in association with NABARD.

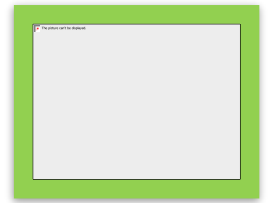
Education is the cornerstone of a developed nation. India after over 7 decades of independence continues to strive towards achieving self-sufficiency and development and education is integral and inseparable to that process.





On 14th of August 2018 at an event organised by CVF called Jashn-e-Azadi, we inaugurated “Samridhi – Apna School” at J.J. Colony, Bakkarwala in West Delhi. This school will be a beacon of hope for the underserved children of thousands of migrant workers living in the area. This school is a pet project of the organisation. We saw the plight of the families of migrant workers, especially the women and children and decided to take proactive initiative and do something for them. The Samridhi dream was finally realized owing to the very generous support of all our donors, supporters and partner organizations. The inauguration event of the school was graced by the presence of notable personalities like Mr. Sandeep Kumar and Mr. V.K. Meena of Delhi Legal Services Authority, Ms. Sarika Chaudhary, member of Delhi Women’s Commission and Mr. Sunil Kumar Gupta, lead District Manager at Canara Bank. The inauguration event was followed by admission of students into the school and each of the admitted students was presented with a small gift hamper of stationery set. This school is a small but significant step towards our nation’s dream of attaining 100 per cent literacy. Presently, the strength of the students in the school is up to 50.



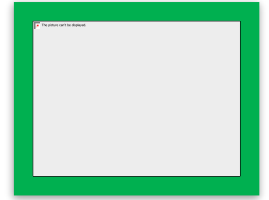

ORGANISING OF 2 DAY FAIR FOR FARMERS

Jute is the second most important vegetable fiber after cotton due to its versatility. Jute is used chiefly to make cloth for wrapping bales of raw cotton, and to make sacks and coarse cloth. The fibers are also woven into curtains, chair coverings, carpets, area rugs, hessian cloth, and backing for linoleum. Jute is called as the golden fiber because it is a cash crop and can be very profitable for the economy as its export can bring in a lot of money into the economy. It is the second most important natural fiber after cotton and its demand is again on the rise in the world. Uttar Pradesh Govt. is working hard to promote jute products in the State.

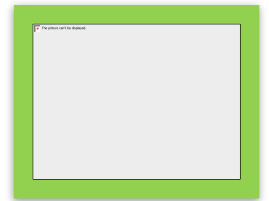
Workshop for the self-help group officials and farmers of the Farmers Producer Association

On 12 December 2019, the organization organized a workshop for the self-help group officials and farmers of the Farmers Producer Association in the Yuva Turk Library and Reading Room of Dr. Babasaheb Ambedkar Aarogyadham, near Indane Gas Agency Block road, Mardah, Gazipur, UP. In this workshop, 15 women officers of the self-help group participated in it. They belong to various Gram Sabha areas like Kodai, Narwar, Ranipur, Manhgawan, Govindpur, Hyderganj etc. Along with this, farmers from different areas of Maradah block were also present. At the beginning of the workshop, the president of the institution, Mr. Vishal Singh, while introducing the people, made the women of the group aware of their main issue of self-employment and other facilities as well as requested to stop single use plastic for the cleanliness drive.



Mr. Sushil Kumar, DDM of NABARD, Mr. Suraj Kant, Manager of Leading Bank along with the manager of Bank of India Union Bank had also graced the occasion with their presence. All the officers of the self-help group were trained by DDM NABARD and other problems related to the bank were resolved by the leading bank manager and other employees of the bank. After this, all the farmers discussed what is the Farmers Producer Association and why it is necessary to create this.





The Director of the institution Smt. Rupa Singh, while emphasizing on women empowerment, told the women to come forward for self-employment. Jute bags were also distributed to women.



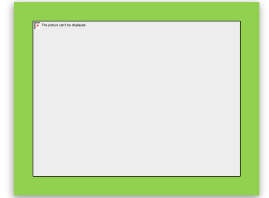
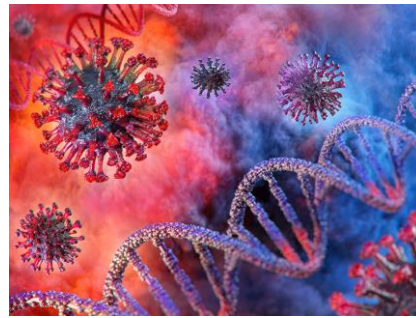
State Level Farmers Producers Organisation Conference

CORONA VIRUS (COVID19) PANDAMIC



The COVID-19 pandemic has infected millions of people and the death toll has surpassed 400,000 across the world. Resource limitations for them has brought in a situation where old aged people tend to neglect their own requirements while prioritizing life and budgets of others in the family and issues. Social stress caused by lockdown has many faces and reasons resulting from travelling restrictions and disruption of cultural celebrations, limited healthcare facilities and interruption in regular immunisations in hospitals leading to anxiety and fear among the population, social distancing with friends and family, closure of places of entertainment and leisure, closure of schools and colleges. The issue of migrant workers was one of the most cruel and highlighted issue in this pandemic where millions were rendered unemployed and stranded without money, food and shelter, crossing the country's highways to return to their villages and several meeting with accidents and deaths on their way. Unemployment has rendered a large section as directionless, leaving the social health as well as economy in shambles. Long term planning and collective efforts of individuals, communities, governments, national and international organisations to fight against this invisible deadly virus is needed.

This situation makes Care Village Foundation empathize the condition of senior citizens who were already victim of loneliness virus, which may not harm them physically but emotionally and mentally. They were and still facing multiple quarantine period these days due to this epidemic. Since they were living in isolation due to nationwide complete lockdown, they were not in a position to survive for a day or two. Team Care Village Foundation, on it's toes, distributed cooked food, ration packages, fruits, sanitizers and/or soaps to the above vulnerable section of the community.

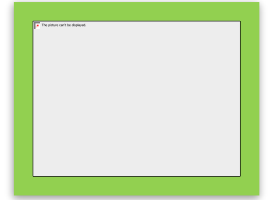

Almost all OPD counters were not operative in major hospitals those days. Therefore, the patients of other problems/diseases were not able to consult the doctors and take medicines. Reaching at the open hospitals was also not possible due to non availability of public transport. Hence, Care Village Foundation organised Health Camps in the area for general check-up and distribution of the medicines. Hundreds of people attended the above health camps and benefited by treatment and getting medicines.





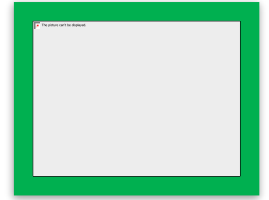
Besides self organised activities, Care Village Foundation also joined hands with other organisations to fight against this pandemic as per details given below :-

➤ Project Annapurna in association with ONGC -

A Proposal for Survival of 252 most Vulnerable Old Age People

We supplied cooked food and food packages(ration items) to 102 permanent residents of an old age home namely 'Anand Ashram, in ward No. 19S, Ranhola, Southern zone of Delhi. Besides, we also helped 150 old people who were staying in temporary shelters, villages, JJ clusters and re-settlement colonies without any help from their successors who were strolling here and there in nearby vicinity in search of food. Many of them were spending their nights at road side, bus stops, religious places etc. We assembled them at Chaupal of Bakkarwala village and other prominent places in West Delhi for distribution of food, fruits, sanitizers and soaps through our team members, volunteers and other social workers. Needless to mention here that the resources for this project were provided by ONGC.





➤ Project 'Rahat' in association with Goonj NGO -

The lockdown imposed due to coronavirus has proven to be catastrophic for India's poor, especially laborers. 90% laborers (approx) have already lost their source of during the lockdown period. What's worse is that despite the Govt. of India announcing a compensation for construction workers whose livelihood has suffered due to the lockdown, it may not be easy for the vast majority of workers to avail the compensation. The lockdown-triggered joblessness has forced a reverse migration of thousands of guest workers across the country resulting in the workforce across various sectors in all the state dwindling, with the construction industry in particular bearing the brunt of the modern day exodus.

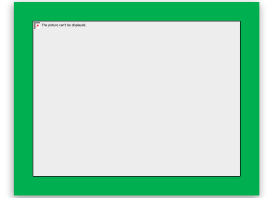
While the medical impact of the COVID-19 pandemic has itself been a major challenge, the economic impact of the lockdown is likely to be even worse. There have already been reports of hunger deaths and of migrant laborers dying trying to walk their way home. It remains to be seen whether the government's relief measures reach those who need them and whether they are even adequate in the first place. The construction workers mentioned that they did not have ration cards and most of them informed they could not access it in their current location as they were migrants. Another major problem is debt. Most these workers mentioned they have loans and they will find it difficult to repay it without employment.





Under these worst situation, Care Village Foundation joined hands with Goonj NGO Under their project "Rahat". We helped Goonj NGO in distribution of food packages(ration items) to hundreds of families of construction labours at Bakkarwala, Nihal Vihar, Loknayakpuram, Bakkarwala, Nangloi construction sites. This major portion of the society was not able to feed themselves, their children and their old parents in lack of wages. We served these people at this difficult time and saved their lives. Besides ration items, we also provided them fruits and hygiene & sanitation items like soap to these people during this period of their isolation and hard to earn a single penny.





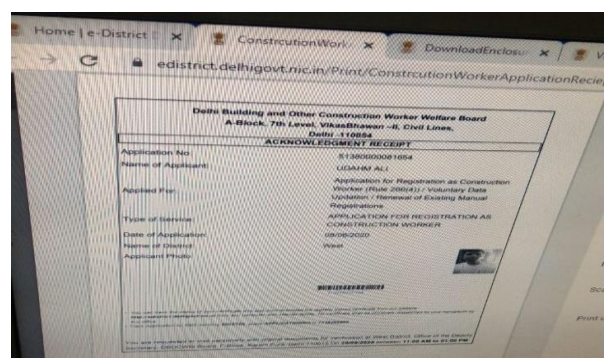

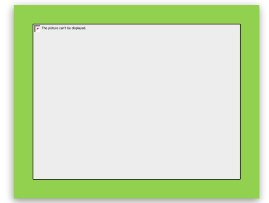

- ❖ Care Village Foundation organized a campaign for applying online application forms for temporary ration cards for general public who are not able to get ration from ration shop due to lack of ration card. We effectively initiated the above activity for two days on 28th & 29th April, 2020 at First Floor, H Block Community Center, JJ Colony Bakkarwala, New Delhi 110 041
- ❖ We again organized this campaign for applying online application forms for temporary ration cards for general public for four days from 30.04.2020 to 03.05.2020 at the same place.

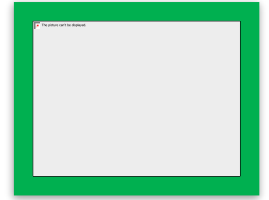

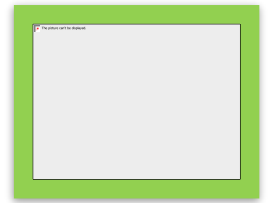

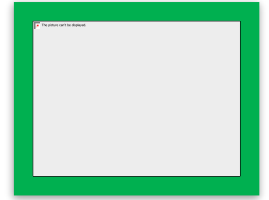
WHAT WE HAVE ACHIEVED SO FAR.....

It is functioning since December'2008 and registered in 2012 with registration No.1329. The organisation is working for social development through counseling, skill development cum training services, yoga awareness campaigns, promotion of sports and cultural activities, formation of community groups (SHGs/JLGs), self employment projects and various other community related activities in collaboration with different Govt./Non-Govt. agencies like MWCD; Nehru Yuva Kendra, Ministry of Youth Affairs & Sports (Government of India); Delhi Tuberculosis Association(DTBA); Liver Care Foundation; Delhi Police; Ministry of Aayush; SEBI; NIIT; SNS Foundation; Jan Shikshan Sansthan Prauas, MHRD GoI; Rajiv Gandhi Cancer Institute & Research Centre(RGCRI); UNHCR; Access Development Services; Sant Kaur Memorial Trust; Jana Urban Services For Transformation Pvt. Ltd. (JUST); Janalakshmi Financial Services Ltd.; Delhi State Legal Services Authority(DSLSA) etc.

We have extended our services and the scope of development to cover vast sections of people including middle class, lower middle class so that we fulfill the vision and mission of the organization.. To maximize the potential of an individual in society, various alternatives are provided at Care Village Foundation. We believe that the complete socio-economic transformation and development of the marginalised, deprived and disadvantaged section of the society can be done only by their capacity building through proper education, skill development, vocational training, personality development, health and hygiene & sanitation awareness.

Care Village Foundation with its dedicated team and invaluable support and commitment from various government and non-government. national as international organisations, donors, supporters and volunteers have accomplished milestones and aspire to continue working relentlessly towards our goals.

- Running a self financed family counseling Centre for the last 3 years where the average turn out of clients is more than 10 clients per month. Out of which 70% of the cases are being solved within the family.



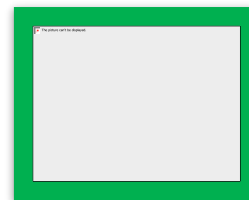
- Annually organizing Bal Sanskar Shivirs (Camps) for children of various social strata, especially underprivileged boys and girls with a view to inculcate a feeling of community living, character building and learning of Art and Craft skills..
- Undertaking Self-defense training camps for girls to generate self-confidence among girls.
- A networking with other NGOs, Department of Social Work both Delhi and out side, Govt. Agencies etc. for the better understanding of social intervention skills.
- Approximately, 3500 girls/women have already been trained in Cutting and Tailoring Trade under our Vocational Training Project to the target group since its inception.
- Approximately 1,325 girls have been trained through beauty training centers of Sampurna.
- Mainstreaming of children in the formal schools is the annual feature of. We run non-formal educational (NFE) centers where children of (3-6years) are prepared to go for formal education.
- Approximately 1,100 children have been sent to school through NFE programme.
- Approx 25,000 people including children have been vaccinated against Hepatitis during 2009-2010. Target oriented awareness campaigns have been conducted on the subjects of AIDS, Cancer, Tuberculosis, Drug Abuse, Road Safety, Consumer Awareness, Population Explosion etc. Annually organized big Health Melas by Care Village Foundation in different parts of North-West Delhi touching attendance to a records figure of 25,000 persons.
- Care Village Foundation has successfully trained more than 1,000 adolescent girls belonging to the underprivileged strata of society in Self-Defense with the assistance of C.A.W. Cell, Delhi Police.
- Care Village Foundation brought a new model of development where a large number of volunteers worked in close association of paid workers.
- We organise Melas where we exhibit & sale our products made and designed by the most vulnerable section of society. We identify, train and then prepare them to exhibit their talent through such exposures.
- Donations and grant-in-aid are the part of funds utilized for running the activities. Care Village Foundation even do not hesitate to run such a small activity like Raddi (Junk) Collection. It doesn't bring any monetary benefit to the NGO but it brings people from privileged class to the service centers of CVF. CVF is a key player in motivating the masses to fight against social problems.

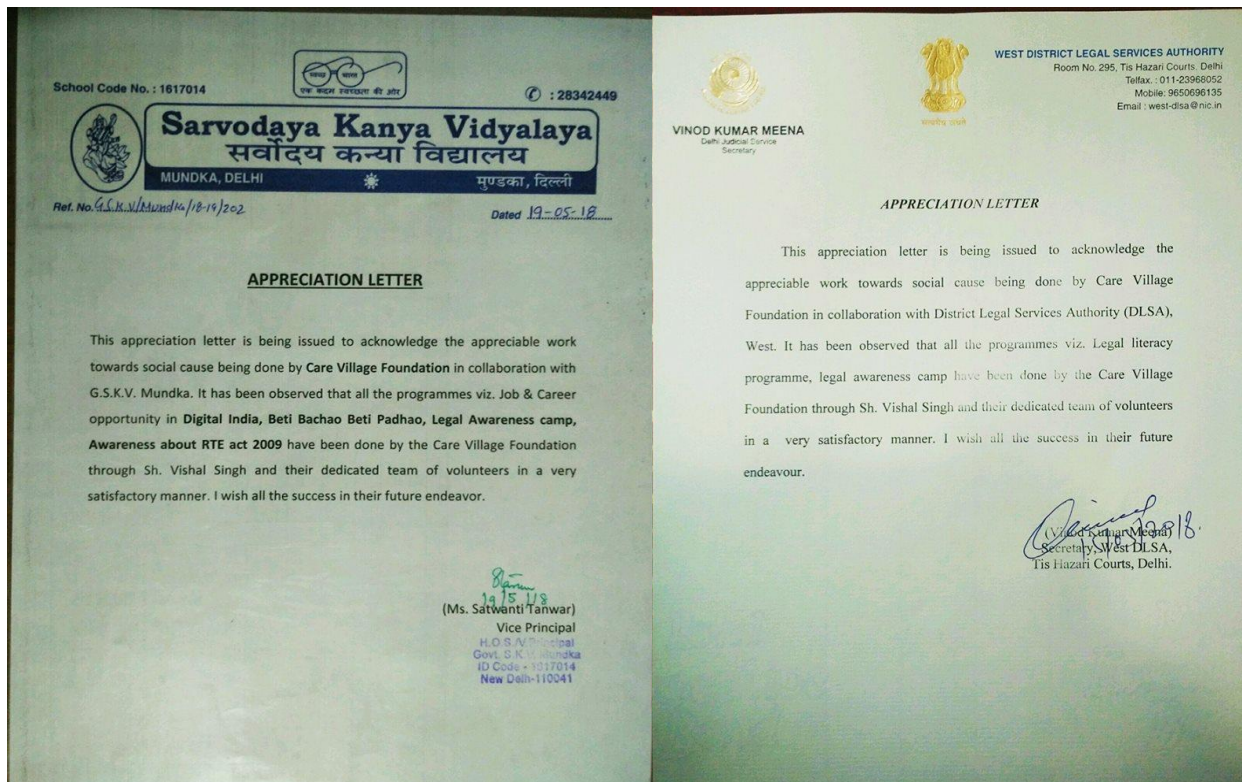

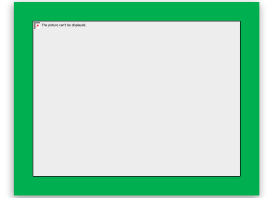

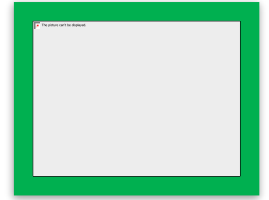
