

Anjali was established in the year 1988. The activities of the organisation were initiated on 29th January 1989.

The founders after completing higher education founded Anjali in order to use their skills & capabilities for the poor and the needy.

Anjali is a voluntary organisation based in village Ranasan. Ranasan with population of 5000 is a village in Talodtaluka of Sabarkantha district in north Gujarat in India

Beginning was made with health activities, the poor and the needy being the target population. The health activities developed progressively and other activities were included as the needs were perceived.

At present the activities of Anjali are, a 75 bed Anjali Hospital, women's programm in 48 interior villages (on the platform of saving groups) and environment enrichment programm. Organisation is inclined towards development programmes for children, youth, and villages

The soil in Ranasan and its vicinity is rocky & sandy and the climate is dry, windy, hot during 7-8 months of the year and cold during the winter months. The rainfall is less and unpredictable. There are two rivers which run if there is ample of rainfall. There are few lakes & other sources of water. The principal vocation of the people is agriculture. There are few industries in the vicinity. The level of education is low. Most of the population is economically & socially weak.

The majority of the population of this area comes from the communities of Thakors, Dalits, Ravals, Vagharis, Banjaras, Vadi, Pagi, Rabarisamaj and migrant adivasi labourers. Most of them earn their livelihood as agriculture or miscellaneous labour. They have not made much progress either economically or socially. This group of people along with other economically weak & distressed section of the population are the main beneficiaries of Anjali's activities.

Ambulance is life line of any hospital. Since beginning Anjali Hospital has Ambulance facility. Periodically with wear & tear vehicle is changed as it has to be up to date. Since last two years Mahindra finance was in talks /discussions regarding Ambulance donation. This year Mahindra Finance from its CSR fund donated Bollero Ambulance (provided fund, from which Mahindra & Mahindra ambulance was purchased) to Anjali Hospital. Because of free& prompt 108 ambulance, it is seldom that ambulance is used to bring patients but patients utilise it to go home after discharge. It is also very frequently used to take admitted patients for sonography, consultant reference, transfer of patients to higher centres and for coming to the hospital by one or two nearby villages. Patients with spine injuries and very old patients use it go for follow up at Ahmedabad or Himatnagar. Surgical operation camps were organized at Ranasan, Poshina & Kasana as done every year. Eye camps were arranged on every Wednesday. Some villages in radius of 25Kms were selected where eye camp will be regularly conducted once in a year. Anjali Hospital already has fulltime eye department. The camp activities in figures are as follows:

Mahendrabhai Hareshbhai Khankhar, aged 15 yrs belongs to Godhavada village in Meghraj Taluka. He came to Anjali Hospital OPD to consult doctor. Seeing his condition as he was not able to walk or sit down, his laboratory investigation swere done, his haemoglobin level in blood was mere 1.6 Gm % (Normal-14-17.5 Gm %). He was admitted. 2 bottles of blood from Anjali hospital blood storage centre & 2 bottles brought from Blood Bank in Himatnagar were transfused. Total 4 bottles of blood were transfused. Besides his diet was also taken care of. Anjali Hospital kitchen provided high protein & nutritional diet. Slowly he started walking. Haemoglobin level in his blood also increased. While counselling during his admission it was revealed that he was chewing tobacco (Gutka) daily in large amounts. With patience and compassion, he was explained that because of his addiction to Gutka he has developed health problems. On discharge he was explained to take care of eating, eat regularly, take medicines regularly and get rid of habit of tobacco. He came for follow up in time. He understood the advice given to him and he obeyed the instructions. After one & half months his haemoglobin level in blood was 9 Gm %, has quit tobacco and is doing well.

2) "GANDHI 150"

The 150th birth anniversary of Rashtrapita Mahatma Gandhi, (Year 2018-19) in being celebtated as "GANDHI 150" throughout the nation, Anjali decided to celebrate the year in its own way. As such Gandhiji is imbibed / should be imbibed in our day to day activities, on this year long occasion, if various activities and discussions are arranged with the young generation and local workers, it will bring freshness in daily activities and they will be able to connect themselves with Gandhiji. A committee of voluntary organisations is formed as part of celebration of "Gandhi 150" in Sabarkantha district, they will conduct programmes in their organisations. We tried to participate in programmes organised by nearby organisations Sahyog Krushtha Yagna Trust, Rajendranagar and Vishvamangalam, Anera.

Children are treasure of energy and enthusiasm. As part of Gandhi 150 celebrations, Anjali, undertook a programm with children of primary schools in nine surrounding villages. School children were engaged in various activities and were given nutritious food. "Ready packed snacks do not provide nutrition" an effort was made to bring awareness about this in mothers and the children. Children were taught to make new things from waste (best from waste) with which they could play, made to sing songs, role plays were performed and games were played. Songs & games related to nutrition were sung and played. Nutritious snacks were given. Children enjoyed being with our team. Mother were taught various recipes children liked, so that they give up eating packed snacks. Activities were performed for three months and at the end, health examination of the children was done (Heart, Lungs, Teeth, Nose, Throat and Eyes) and those in need were given treatment. Alongside mothers were given guidance about children's health.

"Gandhi" film was screened in Anjali's hall in which people form Ranasan village were also invited.

To bring staff workers close to Gandhi, a trip to Gandhi Kutir in Gandhinagar and Gandhi Ashram in Ahmedabad were arranged. Many workers had not been to these places earlier. Every one new about Gandhi but had not seen life of Gandhi through current technology, they were enriched, seeing and experiencing and learnt a lot.

3) Women's Activity:

Monthly meetings were held in each village throughout the year. The attendance is less during agricultural season but overall during the year they participated with enthusiasm in monthly, accounts, annual meetings at Anjali and in arranged tours.

Health was the main topic in every annual meeting of savings groups held at Anjali during the year. "Dental care"-In village when taking care of teeth in particular is talked about, it is taken very lightly. Dental services are available daily at Anjali Hospital. Dental specialist gave information and guidance about why to take care of teeth, how to take care and availability of new methods of treating dental problems. Dental examination of all the women members was done and were given guidance as per the need. Those in need of treatment were given appointment dates. Concessions were provided in treatment (Charges at Anjali Hospital are significantly low compared to private clinics). Experience was that in spite of providing facility many women members did not turn up for dental examination and many who came for examination did not turn up for treatment. They are scared as well as there is lack of seriousness. "One by one repetition of topics covered in earlier annual meetings leads to revision and understanding about that topic". With this objective women member were shown video and given information about "domestic violence".

As done every year seeds of vegetables were given which they take with enthusiasm, sow them, eat vegetables and share it with others.

• Women enjoy one day tour. After talking with them, this year, they were taken to one day tour of Gandhi ashram in Ahmedabad and Gandhi Kutir in Gandhinagar as "Gandhi-150" is being celebrated throughout the world. One of the women managers of Gandhi Ashram nicely talked at length with the women about life of Gandhiji. Gandhiji is all pervading in India. He resides in everybody's heart. Whenever Gandhiji's picture appeared in video, photo, many of the women paid salutations with reverence. They made small purchases from the Gandhi Ashram. Their feeling was "no one would think of taking us to such a holy place for tour, we are fortunate.

- On the occasion of8th March, International Women's Day, women members of 13 villages took out a rally themselves in their villages. In some villages where we could not reach to see, they took photographs and forwarded us. They could spontaneously decide to take out the rally and express to the society their feeling and thoughts.
- Anjali is doing tree plantation every year since many years. Saving group members were given tree saplings twice in earlier years and the experience was good. This year in 4 villages, through joint efforts of saving group members, community tree plantation was done at sights selected by them. Children and villagers also joined them. Community tree plantation was done in Charanvanta, Vajaput, Deodiaand Kathvada villages.
- In year 2009 all the members of saving groups were given free seeds of nutritional grass. Later they were inquiring and asking for getting seeds for them. Meanwhile the cost of seeds had increased significantly. But the members were prepared to pay the cost. Earlier the seeds were obtained from Rajasthan and there was no dealer in Gujarat. They would send the seeds if they have order of truck load. We talked with local businessman. He got the seeds for us. The members were informed and 207 members purchased the seeds. As women are mainly associated with agriculture and animal husbandry, they have good experience of this grass.
- In Women's programme, we have given prominent place to adolescent girl's activities. Earlier this activity was conducted in villages. The girls kept changing and it was realised that there was lack of seriousness. Therefore, in schools of 12 surrounding villages, awareness programme were conducted using various means of communication in relation to menstrual cycle, cleanliness, parts of body, changes in body during adolescence, nutrition, and habits etc. 4 camps of these adolescent girls were organised at Anjali. 467 adolescent girls of schools of 12 villages participated in these camps.
- On occasion of "Gandhi 150" in 9 villages of Women's programme, children activities focusing on nutrition (nutritious food) were conducted

Purpose of loan:

Dadarda is a village in Talod taluka of Sabarkantha district. There are three women's saving groups promoted by Anjali in Dadarda. Dipeshwari Mahila Bachat Mandal is one of them. There are seven members. All are regular. Ushaben Vikramsinh Zala is one of them. Her husband was a freelance driver. His income was small. She informed the saving group members that for her husband, she wanted to bring a vehicle on installments, so that he can work as a driver. She took, in parts, total loan of Rs 70000. Ushaben purchased Maruti Echo vehicle by down payment after adding money from her other savings. Ushaben regularly pays installments from income of the vehicle. Ushaben created self-employment for her husband.

Mali is a village in Himatnagar taluka of Sabarkantha district. There are two women's saving groups promoted by Anjali in Mali. Shri Raj Mahila Bachat Mandal is functional since last 11 years. It has 10 women members. All members very regularly save and make loan transactions. In the beginning all members were farm labourers. Now most of the members in turn have taken loan, regularly repaid and established Cow & Buffalow stables. Their individual savings are Rs 30000. Ramilaben Rohitkumar Vankar joined in the beginning. In phases she has taken loan of Rs 280000 and repaid the loan. Lastly she took loan of Rs 100000 to purchase a buffalo. They have good income. Both Ramilaben & Rohikumar themselves work in the stable and make good income. Saving group was very useful for them.

4) Environment Enrichment Programm – Tree Plantation

In this year, decided to undertake tree plantation at Rayan lake along with on banks of Konjan river, bank of Meshvo river, and open land of Gram panchayat near water tanks. A meeting was held with people of Ranasan village and the matter was discussed. All present in the meeting and Ranasan Gram panchayat agreed. Planning was done accordingly. This year tree plantation was done on empty spaces in Rayan area, bank on Ranasan side of Meshvo river, and in Ranasan village totaling to 1300 trees. Trees planted earlier were cared for and some 250 of undeveloped trees were changed.

This year, the well, from which water was drawn to water the trees caved in while repairs hence there were difficulties in watering the trees. Ranasan based industry Meena Prints came to rescue and made arrangements for watering the trees throughout the year. We are very thankful to them.

5) **Staff Activistes**

Religious and national festivals were celebrated with staff membres during the year .Staff members were taken to tour of Gandhi kutir, Gandhinagar and Gandhi Ashram, Ahmedabad. Participated in training, seminar and meetings.

Anjali has taken up tree plantation since the year 2008-09. Every year after taking permission from Ranasan Gram panchayat we have planted around 5500 trees near Rayan lake area.

This year we decided that till now we have successfully done tree plantation with cooperation of people of Ranasan, now we do tree plantation in neighboring villages. So, we selected road going towards Himatnagar (in between Ranasan and Navalpur village) and plant trees on both sides of the road till Navalpur village. The matter was discussed seriously and at length with people of Navalpurvillage. Most of the villagers gave their consent. For planting trees on the bank of Meshvo river on side of Nava village, meeting was held with people of Nava village and matter was discussed at length.

In the meetings in both the villages consent was given and Anjali's efforts at tress plantation were praised.

Many village people mentioned that "Because of Anjali's tree plantation along the road in Ranasan there is big relief from heat".

These meetings were held in mid-summer in the month of May.

We were delighted and started preparations and planning was done. Began digging pits with JCB mahine. At that time people of Navalpur village whose fields were along the road side objected and work was abandoned. Tree plantation was to be done in road side government land. Their argument was "that due to trees there will be shadow and our production will be less" (If there are trees then there will be rains?). On the bank of Meshvo river and nearby waste land pits were made and fresh soil and manure was brought and kept along each pit and tree plantation was started. At that time people from the village whose land was nearby came and objected. They said if trees will come up here then birds / animals will come and destroy our crops. They threatened and tree plantation in that area was abandoned. All the expense went in waste. The real face of the society was unmasked.

The whole tree plantation team was stunned. Could see the real face of the society. Environment enrichment cannot we done only by talking, reading and forwarding Whats App messages, implementation is more important.

He played a prominent role in founding of Anjali. He organized meeting with his well-wishers and was helpful in raising initial fund for Anjali. Took keen interest in every activity of Anjali. He actively participated in various camps, annual programs of Anjali, Fund raising programs and sneh milan program. He very much liked to give his services in the hospital and whenever he got an opportunity he provided his services. He was well acquainted with Anjali's staff. Provided financial assistance to Anjali. He was elder brother (Motabhai) of Dr Lalitbhai. After knowing that Dr Lalitbhai wanted to work for needy people after becoming doctor, he provided strong backing during the process of giving shape to the idea, till foundation of Anjali.

He was private practitioner in Vadodara since 1971-72. In Vadodara also he was doing ethical and honest practice. He made a place in hearts of his patients. He was found of reading good books especially new and varied spiritual thoughts and discussing them. He provided inspiration to us through discussions. Due to his company we were acquainted with many people in this humanitarian acvtivities and kept encouraging us till his last. He developed Interstitial Lung Fibrosis in 2012. But till his last days he kept is life live and lived fully.

Audit report under section 12A(b) of the Income Tax Act, 1961, in the case of charitable or religious trusts or institutions

I have examined the balance sheet of ANJALII: SOCIETY FOR RURAL HEALTH & DEVELOPMENT (PAN:AAATA2113L) as at 31 March, 2018 and the Profit and loss account for the year ended on that date which are in agreement with the books of account maintained by the said trust or Institution.

I have obtained all the information and explanations which, to the best of our knowledge and belief, were necessary for the purposes of the audit. In my opinion, proper books of accounts have been kept by the head office & branches of the above named trust visited by me so far as appears from our - examination of the books, and proper returns adequate for the purposes of audit have been received from branches not visited by me, subject to the comments given below:

As per audit Report

In my opinion and to the best of my information, and according to information given to me, the said accounts, give a true and fair view:-

- (I) In the case of the balance sheet, of the state of affairs of the above named trust as at 31 March, 2018, and
- (II) In the case of the profit and loss account, of the profit or loss of its accounting year ending on 31 March, 2018.

The prescribed particulars are annexed here to.






